NOTICE IS HEREBY GIVEN pursuant to California Government Code section 65090 et seq., that the Cupertino City Council will conduct a public hearing to consider an urgency ordinance extending a temporary moratorium on certain non-medical marijuana commercial activities for one year.

On October 18, 2016, the City Council adopted Urgency Ordinance No. 16-2153 to impose a moratorium on certain non-medical marijuana commercial activities, consistent with state law. On November 15, 2016, the Council extended the moratorium for 10 months and 15 days, through September 30, 2017, pursuant to Ordinance No. 16-2160.

The proposed ordinance will extend the City's interim moratorium and current prohibitions on non-medical marijuana dispensaries, marijuana cultivation facilities, commercial cannabis activities, and marijuana transport and deliveries for one additional year. The moratorium extension is necessary for the protection of public health and safety in light of the unremitting and accelerated changes in state laws and regulations. Further, the extension will allow the City to complete its review of the public safety impacts of non-medical marijuana activities and associated businesses, to evaluate changes in state regulatory schemes and requirements, and to determine possible updates to the zoning code and municipal code.

Environmental Recommendation: Categorically Exempt. This action is categorically exempt as there is no potential it will cause a significant effect on the environment and/or any project would be exempt under relevant provisions of CEQA guidelines, Section 15061(b)(3) and 15354.
