The City of Cupertino (the City) is intending to adopt a Mitigated Negative Declaration for the Cupertino Pedestrian Transportation Plan in accordance with the California Environmental Quality Act.

SUMMARY PROJECT DESCRIPTION: The project proposes to implement the Pedestrian Transportation Plan, a plan to construct pedestrian network facilities and improvements to existing facilities throughout the City of Cupertino. New facilities would be constructed in existing right-of-way. Larger project components (i.e. pedestrian/bicycle bridges), would be subject to further environmental review to determine extent of environmental impact.

LOCATION OF PROJECT: The Pedestrian Transportation Plan proposes constructing new or improving existing pedestrian facilities throughout the City.

FINDING: On the basis of the Initial Study, the City has determined that with the incorporation of the mitigation measures identified in the Initial Study, the proposed project would not have a significant adverse effect on the environment.
