NOTICE IS HEREBY GIVEN that at their regular meeting on **Tuesday, December 1, 2020 at 6:45 p.m.**, the City Council of the City of Cupertino will conduct a public hearing to consider Municipal Code Amendments to Mobile Vending regulations, including but not limited to regulations in Chapter 5.48, and potential conforming edits to other chapters in the Municipal Code, including in Titles 5, 11, 13 and 19; Applicant(s): City of Cupertino; Location: city-wide. Application No(s): MCA-2020-004. At a regular meeting of the Planning Commission held on Tuesday, October 27, 2020, the Commission recommended that the City Council adopt amendments to the City's Municipal Code to update the existing Mobile Vendor regulations per Resolution #6913 by vote of 3-2-0 (Takahashi and Fung voting no).
