CITY OF CUPERTINO NOTICE OF PUBLIC HEARING TRANSITION FROM LEVEL OF SERVICE (LOS) TO VEHICLE MILES TRAVELED (VMT)

NOTICE IS HEREBY GIVEN that at their regular meeting on **Tuesday, February 16, 2021 at 6:45 p.m.**, the City Council of the City of Cupertino will conduct a public hearing to consider proposed amendments to add a new section to the Cupertino Municipal Code that will include Vehicle Miles Traveled (VMT) standards, used to determine transportation impacts under CEQA (California Environmental Quality Act), a change required by California Senate Bill (SB) 743.

At a regular meeting of the Planning Commission on January 26, 2021, the Planning Commission recommended approval of a new Ordinance for Vehicle Miles Traveled standards by a vote of 4-0-1 (Saxena absent) per Resolution #6917. If you have any questions, need additional information or to send written comments, contact the Planning Department at **(408) 777-3308** or planning@cupertino.org, or the Department of Public Works at **(408) 777-3354** or public_works@cupertino.org. **In accordance with Governor Newsom's Executive Order No-29-20, this will be a teleconference meeting without a physical location. Members of the public will be able to observe and address the meeting telephonically or otherwise electronically from the City's website through procedures that will be detailed in the published meeting agenda.** If you wish to challenge the City Council's action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written or electronic correspondence delivered to the City of Cupertino City Hall 10300 Torre Avenue, Cupertino, CA 95014 at, or prior to, the meeting.
