NOTICE IS HEREBY GIVEN that at their regular meeting on **Tuesday, February 16, 2021 at 6:45 p.m.**, the City Council of the City of Cupertino will conduct a public hearing to consider a proposed modification to an existing Use Permit (U-2004-01) to amend the conditions of approval to allow non-retail uses where only 50% had been allowed. Applicant(s): Catherine Chen (Cupertino Adobe, LLC); Location: 20132 Stevens Creek Blvd APN #369-56-001. Application No(s): M-2020-002. At a regular meeting of the Planning Commission on January 26, 2021, the Planning Commission recommended approval of a modification to a Use Permit by a vote of 4-0-1 (Saxena absent) per resolution #691G.
