NOTICE IS HEREBY GIVEN that at its regular meeting of Tuesday, March 2, 2021, the Cupertino City Council conducted the first reading of Ordinance No. 21-2224 as amended: "An Ordinance of the City Council of the City of Cupertino amending City Code Chapter 10.90 of Title 10 (Public Peace, Safety, and Morals) to prohibit smoking in multi-unit housing and certain outdoor areas." Ayes: Paul Chao, Moore, Wei, and Willey, Noes: None, Abstain: None, Absent: None. The second reading is scheduled for Tuesday, April 6, 2021, at 6:45 p.m. In accordance with Governor Newsom's Executive Order No-29-20, this will be a teleconference meeting without a physical location. All interested parties are invited to attend the teleconference and address the City Council. Instructions for participation will be published in the Council agenda. If you wish to challenge the City Council's action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written or electronic correspondence delivered to the City of Cupertino City Hall at, or prior to, the meeting.
