NOTICE IS HEREBY GIVEN that at its regular meeting of Tuesday, April 6, 2021, the Cupertino City Council conducted the second reading of Ordinance No. 21-2225: "An Ordinance of the City Council of the City of Cupertino Amending City Code to add 19.102: Glass and Lighting Standards and to Amend Chapter 19.40 Residential Hillside (RHS) Zones, Chapter 19.60 General Commercial (GC) Zones, Chapter 19.72 Light Industrial (ML) and Industrial Park (MP) Zones, and Chapter 19.124 Parking Regulations to Implement Bird-safe and Dark Sky Policies. Ayes: Paul, Chao, Moore, Wei and Willey. Noes: None. Abstain: None. Absent: None. This ordinance was enacted and will go into effect thirty (30) days from that date.
