NOTICE IS HEREBY GIVEN that at its regular meeting of Tuesday, April 20, 2021, the Cupertino City Council conducted the first reading of Ordinance No. 21-2226: "An Ordinance of the City Council of the City of Cupertino Amending Cupertino Municipal Code Section 19.56.030A (Table 19.56.030) and 19.56.030F (Density Bonus Ordinance) to Incentivize the Development of Affordable Housing by Allowing for Density Bonuses of up to 40 Percent" which includes a finding that the proposed actions are exempt from CEQA. The second reading is scheduled for Tuesday, May 4, 2021, at 6:45 p.m. in accordance with Governor Newsom's Executive Order No-29-20, this will be a teleconference meeting without a physical location.
