NOTICE IS HEREBY GIVEN that at its regular meeting of Tuesday, May 4, 2021, the Cupertino City Council conducted the first reading of Ordinance No. 21-2227: "An Ordinance of the City Council of the City of Cupertino amending City Code Chapter 10.90 of Title 10 (Public Peace, Safety, and Morals) to prohibit smoking in multi-unit housing and certain outdoor areas," which adds setback requirements for designated smoking areas and includes detached ADUs and JADUs in the regulations, and which includes a finding that the Ordinance is exempt from CEQA. Ayes: Paul, Moore, and Willey. Noes: Chao and Wei. Abstain: None. Absent: None. The second reading is scheduled for Tuesday, May 18, 2021, at 6:45 p.m. In accordance with Governor Newsom's Executive Order No-29-20, this will be a teleconference meeting without a physical location. Complete copies may be requested by contacting the City Clerk's office by email at [cityclerk@cupertino.org](mailto:cityclerk@cupertino.org) or by telephone at 408-777-3223. All interested parties are invited to attend the teleconference and address the City Council. Instructions for participation will be published in the Council agenda. If you wish to challenge the City Council's action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written or electronic correspondence delivered to the City of Cupertino City Hall at, or prior to, the meeting. IMPORTANT NOTICE: Please be advised that pursuant to Cupertino Municipal Code 2.08.100 written communications sent to the Cupertino City Council, Commissioners or City staff concerning a matter on the agenda are included as supplemental material to the agenda item. These written communications are accessible to the public through the City's website and kept in packet archives.
