NOTICE IS HEREBY GIVEN that at its regular meeting of Tuesday, June 1, 2021, the Cupertino City Council conducted the second reading of Ordinance No. 21-2227: "An Ordinance of the City Council of the City of Cupertino amending City Code Chapter 10.90 of Title 10 (Public Peace, Safety, and Morals) to prohibit smoking in multi-unit housing and certain outdoor areas," with multi-unit housing /residence defined for the purposes of this Ordinance to include attached single family homes and other property containing two or more attached units, which includes a finding that adoption of the ordinance is exempt from the California Environmental Quality Act.
