NOTICE IS HEREBY GIVEN that at their regular meeting on **Tuesday, August 17, 2021 at 6:45 p.m.**, the City Council of the City of Cupertino will conduct a public hearing to consider approval of a Vesting Tentative Map to replace a previously approved Vesting Tentative Map (TM-2018-03) for the Westport Cupertino development project to create a separate parcel for the age restricted senior below market rate building. City approval would be a Vesting Tentative Map; (Application No(s): TM-2021-002; Applicant(s): KT Urban (Mark Tersini); Location: 21267 Stevens Creek Boulevard; APN #326-27-042, -043. The Planning Commission considered the Vesting Tentative Map at its regular meeting on Tuesday, July 27, 2021 and recommended with a 4-1 vote (No: Wang) that the Council adopt the resolution approving the Vesting Map (TM-2021-002).
